

To date, the FDA has authorized 34 e-cigarette products and devices.

These are the only e-cigarette products that currently may be lawfully sold in the U.S.

New tobacco products on the market without the required premarket authorization are adulterated and misbranded under the FD&C Act and are subject to FDA enforcement action.

FDA's Tobacco Products Enforcement Priorities

Enforcing against unauthorized ENDS products, including unauthorized products popular with youth, are among FDA's highest enforcement priorities.

A new tobacco product <u>must</u> have FDA authorization before it can be legally marketed, and generally, products without authorization are at risk of enforcement action.
